Please note:

The \$100 non-refundable application fee includes a one year membership to MEPI. MEPI membership beyond the first year is each student's responsibility. Membership in MEPI must be maintained in order to apply for certification.

Supplies which are necessary for making projects and other classroom materials are the students' responsibility.

Student interns receive a minimum of three visits from qualified field supervisors, approved by the Program Director. Interns are responsible for the miscellaneous costs associated with the visits. These costs include travel and lodging. In situations where there is no supervising Director available, interns receive monthly visits. In pioneering situations, when monthly visits pose an undue hardship, Program Directors may elect to mentor students via monthly conference calls, Skype visits, videotaped supervisions, or other methods of communication. Interns are responsible for the miscellaneous costs associated with all visits.
